- HB 2423 ** **Subsequent Referral(s) to Ways and Means
Establishes the Task Force on Licensed Health Care Services in Oregon Schools.
- HB 3365 ** **Subsequent Referral(s) to Ways and Means
Directs the State Board of Education to include an interdisciplinary approach to sustainability and climate change across all subjects for which academic content standards are established.
- HB 3444
Modifies the percentage of amounts that school districts must pay from the State School Fund to public charter schools that are not virtual public charter schools.

- HB 3169 ** **Subsequent Referral(s) to Ways and Means
Directs the Oregon Health Authority to modify the amounts of grants for school-based health centers for inflation.
- HB 2729 ** **Subsequent Referral(s) to Ways and Means
Directs the Oregon Health Authority to modify the amounts of grants for school-based health centers for inflation.
- HB 3063
Provides that a student who is in a hospital educational program shall continue to remain enrolled in the school district in which the student had been a resident prior to being in the hospital educational program only for the purpose of maintaining access to classroom curricula and associated technology.
