HB 2529 \*\* \*\*Subsequent Referral(s) to Ways and Means Prescribes requirements for a cardiac emergency response plan for each school.

HB 2681

Appropriates moneys from the General Fund to the Department of Education for career and technical student organization grants and for activities related to career and technical education that can lead to high wage and high demand jobs.

#### HB 3004 \*\*

\*\*Subsequent Referral(s) to Ways and Means Directs the Youth Development Division to establish a statewide community violence prevention program.

HB 3038 \*\*

\*\*Subsequent Referral(s) to Ways and Means

- Adjusts purposes and eligible recipients of grants related to STEM education.

\*\*Subsequent Referral(s) to Ways and Means

Requires that moneys from the corporate income and excise tax kicker be used for the funding of school construction and maintenance projects and infrastructure improvements.

HB 3449

Allows moneys available for a pilot program to provide support to foster child students to be used in other schools of the grantee's school district.

HB 3562 \*\* \*\*Subsequent Referral(s) to Ways and Means Directs schools to prepare school maps for use by local and state public safety agencies responsible for emergency services at the school.

#### HB 3624 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs education service districts to reimburse parents and legal guardians for fees incurred by parents and legal guardians related to examinations administered to homeschooled children.

HB 3807

Prescribes requirements that an organization that administers interscholastic activities, or that facilitates the scheduling and programming of interscholastic activities, must implement to address discriminatory harassment or bullying behavior.

HB 3941 \*\* \*\*Subsequent Referral(s) to Ways and Means Directs the Department of Education to establish and administer a grant program for community schools.
