HB 2009 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires the Department of Education to study the adequacy of public education in this state. HB 2251

Directs school districts to adopt a policy that prohibits the use of student personal electronic devices.

HB 2359 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires school districts and public charter schools to implement a schedule for high schools that does not start regular instructional hours before 8:30 a.

2673 \*\* HB

\*\*Subsequent Referral(s) to Ways and Means Appropriates moneys to the Department of Education to establish an accreditation program for school business professionals.

#### 3040 HB

Requires the Department of Education to study methods for improving early literacy outcomes. HB 3199

Requires the Legislative Policy and Research Director to conduct a study regarding policies, grant programs, support programs and other initiatives implemented in this state with the intent of improving school attendance.

HB 3373

Directs the Department of Education to prepare and distribute a report that compiles the audit findings for school districts, education service districts and public charter schools.

Allows virtual public charter schools that do not provide educational services through a for-profit entity that contracts with the governing body of the virtual public charter school to be eligible for grants distributed from the Student Investment Account.

HB 3059 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires the Department of Human Services and the Department of Education to jointly study the needs of youth who are in a residential facility and who attend a public school in this state.
