Work Session

- HB 2009 ** **Subsequent Referral(s) to Ways and Means
Requires the Department of Education to study the adequacy of public education in this state.
- HB 2251
Directs school districts to adopt a policy that prohibits the use of student personal electronic devices.
- HB 2359 ** **Subsequent Referral(s) to Ways and Means
Requires school districts and public charter schools to implement a schedule for high schools that does not start regular instructional hours before 8:30 a.
- HB 2583
Allows virtual public charter schools that do not provide educational services through a for-profit entity that contracts with the governing body of the virtual public charter school to be eligible for grants distributed from the Student Investment Account.
- HB 2588 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys from the General Fund to the Teacher Standards and Practices Commission to support the Oregon Registered Teaching Apprenticeship Program.
- HB 2900
Clarifies the definitions of "contract teacher" and "probationary teacher."
- HB 2992 ** **Subsequent Referral(s) to Ways and Means
Directs the Department of Education and the Oregon Health Authority to jointly establish and implement a program that provides eye examinations and prescription eyeglasses to students from low-income families.
- HB 3004 ** **Subsequent Referral(s) to Ways and Means
Directs the Youth Development Division to establish a statewide community violence prevention program.
- HB 3007
Prescribes the requirements of a form to be used when a public education provider receives notification that a student has been diagnosed with a concussion or other brain injury.

HB 3040

Requires the Department of Education to study methods for improving early literacy outcomes.

HB 3199

Requires the Legislative Policy and Research Director to conduct a study regarding policies, grant programs, support programs and other initiatives implemented in this state with the intent of improving school attendance.

HB 3200 **

**Subsequent Referral(s) to Ways and Means

Requires the Department of Education to allocate a specified amount from the Fund for Student Success to the scholarship program for diverse teacher candidates in the biennium beginning July 1, 2025.

HB 3357

Directs the Department of Education to implement a method to be used by school districts and education service districts to record school workplace safety incidents.

HB 3360 **

**Subsequent Referral(s) to Ways and Means

Requires that moneys from the corporate income and excise tax kicker be used for the funding of school construction and maintenance projects and infrastructure improvements.

HB 3365 **

**Subsequent Referral(s) to Ways and Means

Directs the State Board of Education to include an interdisciplinary approach to sustainability and climate change across all subjects for which academic content standards are established.

HB 3373

Directs the Department of Education to prepare and distribute a report that compiles the audit findings for school districts, education service districts and public charter schools.

HB 3563

Requires the Department of Education to study the statutory requirements related to reports of abuse and sexual conduct in public schools.

HB 3568 **

**Subsequent Referral(s) to Ways and Means

Appropriates moneys to the Department of Education for distribution to the Oregon Coast Visitors Association for the purpose of promoting seafood in the public schools of this state.

HB 3652

Expands the requirement to discuss class size and caseload as mandatory subjects of bargaining for purposes of school district collective bargaining.

HB 3807

Prescribes requirements that an organization that administers interscholastic activities, or that facilitates the scheduling and programming of interscholastic activities, must implement to address discriminatory harassment or bullying behavior.

HB 3941 **

**Subsequent Referral(s) to Ways and Means

Directs the Department of Education to establish and administer a grant program for community schools.

HB 2453

Requires the Department of Education to study the adequacy of public education in this state.

HB 2530

Modifies school bus stop arm camera law.

HB 3915 **

**Subsequent Referral(s) to Ways and Means

Directs the State Department of Agriculture to develop and maintain a model list of low-impact pesticides for use with school integrated pest management plans.

HB 3949

Prescribes requirements related to contracts entered into between the State Board of Education and a publisher of textbooks and instructional materials.

Note change: HB 2009, HB 2251, HB 2359, HB 3004, HB 3040, HB 3199, HB 3360, HB 3373, HB 3652, and HB 3941 added.
