#### Public Hearing

SB 1098

Prohibits discrimination when selecting or retaining school library materials, textbooks or instructional materials or when developing and implementing a curriculum.

#### Work Session

SB 805

Reduces the duration of time that the Teacher Standards and Practices Commission is required to wait for verification that attempts were made to resolve a complaint through the processes of the school district before the commission no longer has a duty to investigate the complaint.

SB 867 A

Prescribes sanctions that the Department of Education may impose when an elementary or secondary school or program is found to be in noncompliance with a discrimination prohibition.
