#### Public Hearing

SB 982

Authorizes school districts to use public funds for out-of-state placement of students only if specified criteria are satisfied.

SB 1109 A

Requires specified boards of educational institutions to video record their governing meetings.

#### Work Session

SB 905

Eliminates reporting redundancies required under a Healthy and Safe Schools Plan.

SB 315 A

Directs the Department of Education to review, make recommendations and develop best practices related to the recording of student absences and how school districts respond to student absences and to develop a common coding system for school districts to use for student absences.
