#### Work Session

SB 150 A

CARRIED OVER FROM THE 5-13-2025 MEETING: Prohibits receiving compensation for performing certain services for or on behalf of an applicant or a claimant for a veteran's benefit except as provided in applicable federal or state law.

SB 181 A

Prohibits a research facility from using public funds to directly fund medically unnecessary laboratory research on dogs or cats that is classified under certain pain and distress categories.

SB 459

CARRIED OVER FROM THE 5-13-2025 MEETING: Removes the requirement that a licensee member of the Oregon Board of Maritime Pilots be a resident of this state.

SB 838 A

Provides that the Public Contracting Code does not apply to the contracting activities of the State Parks and Recreation Department, except with respect to surplus property.

SB 947 A

CARRIED OVER FROM THE 5-13-2025 MEETING: Modifies terminology by changing statutory references to "militia" to "National Guard."

***Note Change: SB 150 A, SB 459, and SB 947 A have been added.***
