#### Public Hearing

HB 3008 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Appropriates moneys to fund child care workforce investments.

HB 3011 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Establishes the Early Childhood Education Workforce Development Fund and appropriates moneys in the fund to the Higher Education Coordinating Commission to provide funding to community colleges and public universities in this state that offer early childhood education degrees and certificates.

HB 3053 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Provides moneys to the Higher Education Coordinating Commission to be distributed to the University of Oregon for purposes of a pilot program training graduate-level students who are learning to become speech-language pathologists to use a family-centered approach when serving children with augmentative and alternative communication needs in a traditional overnight summer camp setting.
