Public Hearing

- HB 2686 ** **Subsequent Referral(s) to Ways and Means
Provides funding to the Higher Education Coordinating Commission for purposes of providing a grant to an organization that manages a statewide strategy to re-enroll residents of this state into certain programs.
- HB 2841 ** **Subsequent Referral(s) to Ways and Means
Requires each community college and public university to have at least 65 percent of the total number of credit hours offered to be taught by full-time employees of the college or university during the 2026-2027 academic year and at least 75 percent of the total number of credit hours offered to be taught by full-time employees every academic year thereafter.
- HB 2997 ** **Subsequent Referral(s) to Ways and Means
Requires the Higher Education Coordinating Commission to establish a grant program for the purpose of supporting organizations to expand the scope and community reach of college access and success programs.
- HB 3219 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys to the Higher Education Coordinating Commission for distribution to the Oregon Hazards Lab at the University of Oregon.
