HB 3534 **

**Subsequent Referral(s) to Ways and Means

Provides for a waiver of tuition, fees and the cost of textbooks for veterans and the children of veterans from eligible post-secondary institutions.

HB 3694

Modifies provisions of law related to compensation for student athletes enrolled in a post-secondary institution of education.

HB 3700

Directs the Environmental Quality Commission to adopt by rule standards for certification of sewage treatment works operators from nonreciprocal states, provinces or other certifying entities.

HB 3731

Provides additional data to be included by institutions of higher education in an annual report regarding allegations of sexual misconduct and violence on the campus of the institution.

HB 3809

Appropriates moneys from the General Fund to the Housing and Community Services Department for the individual development account program.

HB 3826 **

**Subsequent Referral(s) to Ways and Means

Establishes a program within the Higher Education Coordinating Commission to promote workforce development initiatives in the trucking industry.

HB 3920

Increases the age limit for tuition waivers for qualified students.
