### **Public Hearing**

HB 2347

Authorizes the Department of Land Conservation and Development to provide planning assistance for housing production to federally recognized Indian tribes.

HB 3136

Removes a requirement that a maximum of two real estate professionals may serve on a city or county planning commission.

HB 3137

Modifies laws related to regulation of real estate professionals.

HB 3034

Modifies the role of the Oregon Housing Stability Council in designing policy for Emergency Housing Account programs.

HB 3035

Expands Housing and Community Services Department authority regarding homeownership housing projects and lending.

HB 2438

Prohibits a person from denying a real estate licensee access to the multiple listing service because the licensee is not a member of a professional real estate association or organization.
