Repeals the prohibition on local rent control.

HB 3877 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires the Department of Consumer and Business Services to establish a rental licensing program for the annual licensing of dwelling units for rental or vacation occupancy.

HB 3757

Allows owners of rural land on which a dwelling is sited to divide the land to add up to four additional dwellings.
