SB 974 A

CARRIED OVER FROM THE 5/19/2025 MEETING: Requires local governments or special districts to complete final review of final engineering plans for residential development within 90 days of submission.

SB 586 A

CARRIED OVER FROM THE 5/19/2025 MEETING: Allows a landlord to pay a tenant one month's rent to reduce from 90 to 60 days the termination notice period that a landlord must give the tenant when selling the dwelling unit to buyers who intend to reside in the unit.
