Public Hearing

- HB 2469 ** **Subsequent Referral(s) to Ways and Means
Establishes a time limit on when a district attorney may submit an indictment to the grand jury on a pending case when a trial date has been scheduled.
- HB 2640
Repeals a manner of committing the crime of harassment.
- HB 2641
Modifies when a prior conviction is admissible to impeach the character of a witness.
- HB 2473 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 2-25-2025 MEETING: Modifies the requirements for providing a declaration for the purposes of authenticating records in response to criminal process.

Work Session

- HB 2055
CARRIED OVER FROM THE 2-25-2025 MEETING: Provides that when offering a service with age restrictions, a private entity is allowed to swipe a driver's license to verify a person's age, regardless of how old the person looks.
- HB 2460
CARRIED OVER FROM THE 2-25-2025 MEETING: Updates, reorganizes and modifies the provisions governing appeals from justice courts that have not become courts of record.
- HB 2613
CARRIED OVER FROM THE 2-25-2025 MEETING: Requires the Department of Human Services to study how to improve services provided to victims of child abuse in this state.
- HB 2638
CARRIED OVER FROM THE 2-25-2025 MEETING: Modifies the court's authority regarding the parties' property rights while a proceeding to terminate a marriage is pending.

Note change: HB 2473, HB 2055, HB 2460, HB 2613, HB 2638 has been carried over.
