Public Hearing and Possible Work Session

HB 2492

Requires the State Court Administrator to study courts and submit findings to the interim committees of the Legislative Assembly related to the judiciary not later than September 15, 2026.

HB 2605

Requires the State Court Administrator to study fees and submit findings to the interim committees of the Legislative Assembly related to the judiciary not later than September 15, 2026.

HB 3067 **

**Subsequent Referral(s) to Ways and Means

Directs the Oregon Criminal Justice Commission to study repealing the sunset of the Justice Reinvestment Program.

HB 3069

Requires the Department of Public Safety Standards and Training to study public safety. HB 3825

Shortens the time period after which judgment remedies for monetary obligations in criminal judgments without restitution expire.

HB 3816

CARRIED OVER FROM THE 4/1/2025 MEETING: Requires the Department of Justice to study victims.

Work Session

HB 2306

Allows the Marion County board of county commissioners to establish a justice of the peace district that includes the county seat.

HB 2668

Requires certain private persons, before engaging in search and rescue efforts, to make specified disclosures to the family of the missing person and to notify county sheriffs.

HB 2851

Modifies the definition of "critical infrastructure" to include a terrestrial-based cable or wire communication facility for purposes of the crimes of domestic terrorism in the first degree and domestic terrorism in the second degree.

HB 3075

Modifies the firearm permit provisions of Ballot Measure 114 (2022).

HB 3076 **

**Subsequent Referral(s) to Ways and Means Directs the Department of Justice to study the establishment of a state gun dealer licensing program, and to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.

HB 3080

Modifies provisions regarding who can act as a health care representative for an incapacitated person who has not appointed a health care representative or does not have an advance directive. HB 3093 **

**Subsequent Referral(s) to Ways and Means

Requires law enforcement agencies to take a DNA sample of a person arrested for certain crimes. HB 3118

Requires the Department of Corrections to enter into a contract with a third party to provide communications services at no cost to persons confined at a Department of Corrections institution.

HB 3819

Allows the State Board of Massage Therapists to issue a registration to practice reflexology to a qualified applicant.

HB 3929

Establishes a testimonial privilege for communications by certain public safety employees to a peer supporter.

HB 2473 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4/1/2025 MEETING: Modifies the requirements for providing a declaration for the purposes of authenticating records in response to criminal process.

HB 2632

CARRIED OVER FROM THE 4/1/2025 MEETING: Directs the Oregon Criminal Justice Commission to study issues related to specialty courts, and to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.

HB 2633

CARRIED OVER FROM THE 4/1/2025 MEETING: Directs the Oregon Criminal Justice Commission to study issues related to specialty courts, and to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.

HB 2639

CARRIED OVER FROM THE 4/1/2025 MEETING: Modifies the process for setting aside convictions, dismissals, contempt of court findings and guilty except for insanity judgments. HB 2677 ** **Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4/1/2025 MEETING: Modifies the procedure for the expunction of certain juvenile records.

HB 2975

CARRIED OVER FROM THE 4/1/2025 MEETING: Provides that an admission or a finding that a crime constitutes domestic violence is not an element of the crime for merger purposes.

HB 3666

CARRIED OVER FROM THE 4/1/2025 MEETING: Requires an electric public utility to apply for a wildfire safety certification.
