#### Public Hearing and Possible Work Session

- HB 2175 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Creates the crime of possessing, purchasing, making, delivering or selling a pill press or similar equipment.
- HB 2641  
Modifies when a prior conviction is admissible to impeach the character of a witness.
- HB 3553  
Creates the crime of possessing, purchasing, making, delivering or selling a pill press or similar equipment.
- HB 3839  
Directs the Department of State Police to ensure that level one and level two sex offender information is available to school districts and entities providing school visitor management services.
- HB 3948  
Increases the penalty for operating an unmanned aircraft system over a critical infrastructure facility that is a correctional facility or youth correction facility.

#### Work Session

- HB 2299  
Increases the penalty for unlawful dissemination of an intimate image and renames the crime.
- HB 2306  
Allows the Marion County board of county commissioners to establish a justice of the peace district that includes the county seat.
- HB 2311  
CARRIED OVER FROM THE 4/3/2025 MEETING: Provides that the Oregon Health Authority is not required to use administrative law judges from the Office of Administrative Hearings for contested case hearings involving the Oregon State Hospital.

- HB 2469 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Establishes a time limit on when a district attorney may submit an indictment to the grand jury on a pending case when a trial date has been scheduled.
- HB 2473 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Modifies the requirements for providing a declaration for the purposes of authenticating records in response to criminal process.
- HB 2492  
Requires the State Court Administrator to study courts and submit findings to the interim committees of the Legislative Assembly related to the judiciary not later than September 15, 2026.
- HB 2522 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires the use of headlights when the windshield wipers are on or there is fog.
- HB 2614  
Directs the Oregon Public Defense Commission to study ways to improve the provision of public defense services within this state, and to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.
- HB 2632  
Directs the Oregon Criminal Justice Commission to study issues related to specialty courts, and to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.
- HB 2639  
Modifies the process for setting aside convictions, dismissals, contempt of court findings and guilty except for insanity judgments.
- HB 2712 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Provides that the Judicial Department may implement an audit schedule for the circuit courts.
- HB 2975  
Provides that an admission or a finding that a crime constitutes domestic violence is not an element of the crime for merger purposes.
- HB 3075  
Modifies the firearm permit provisions of Ballot Measure 114 (2022).
- HB 3076 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs the Department of Justice to study the establishment of a state gun dealer licensing program, and to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.
- HB 3093 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM THE 4/3/2025 MEETING: Requires law enforcement agencies to take a DNA sample of a person arrested for certain crimes.
- HB 3097  
Increases sentencing guidelines for felony attempting to elude a police officer.
- HB 3194  
Establishes that landowners and persons acting as farmworker camp operators are jointly and severally liable for operating a farmworker camp on the landowner's property unless certain conditions are met.
- HB 3426  
Expands offenses relating to the use of an unmanned aircraft system to interfere with official duties to include firefighting and search and rescue efforts.

HB 3564

Modifies provisions relating to demands for correction or retraction of a published defamatory statement.

HB 3582

Eliminates the statute of limitations for civil actions based on sexual assault or child sexual abuse.

HB 3666

CARRIED OVER FROM THE 4/3/2025 MEETING: Requires an electric public utility to apply for a wildfire safety certification.

HB 3766

Allows a plaintiff to bring a civil action against a person who transmits an intimate image to the plaintiff's computer or electronic device in certain circumstances.

HB 3816

CARRIED OVER FROM THE 4/3/2025 MEETING: Requires the Department of Justice to study victims.

HB 3819

Allows the State Board of Massage Therapists to issue a registration to practice reflexology to a qualified applicant.

HB 3825

Shortens the time period after which judgment remedies for monetary obligations in criminal judgments without restitution expire.

HB 3884

CARRIED OVER FROM THE 4/3/2025 MEETING: Requires the Department of State Police to study whether firearm hold agreements reduce firearm risks.

HB 3929

CARRIED OVER FROM THE 4/3/2025 MEETING: Establishes a testimonial privilege for communications by certain public safety employees to a peer supporter.

***Note change: HB 2311, HB 3093, HB 3666, HB 3816, HB 3884, and HB 3929 carried over.***

***Note change: HB 2533, HB 2851, HB 3443 have been removed.***
