Public Hearing and Possible Work Session

- HB 3926 ** **Subsequent Referral(s) to Ways and Means
Directs the Department of State Police to create the SIGNAL program (State Initiated Guidance for Notifying and Assisting the Lost).
- HB 3935
Creates the crime of initiating a false report in the first degree.

- HB 2175 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 4/7/2025 MEETING: Creates the crime of possessing, purchasing, making, delivering or selling a pill press or similar equipment.
- HB 2299
CARRIED OVER FROM THE 4/7/2025 MEETING: Increases the penalty for unlawful dissemination of an intimate image and renames the crime.
- HB 2311
CARRIED OVER FROM THE 4/7/2025 MEETING: Provides that the Oregon Health Authority is not required to use administrative law judges from the Office of Administrative Hearings for contested case hearings involving the Oregon State Hospital.
- HB 2467 ** **Subsequent Referral(s) to Ways and Means
Defines "dangerous to self," "dangerous to others" and "serious physical harm" for the purpose of involuntarily committing a person with mental illness.
- HB 2469 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 4/7/2025 MEETING: Establishes a time limit on when a district attorney may submit an indictment to the grand jury on a pending case when a trial date has been scheduled.
- HB 2470 ** **Subsequent Referral(s) to Ways and Means
Directs the Oregon Health Authority to expand the capacity of the Oregon State Hospital.

- HB 2473 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 4/7/2025 MEETING: Modifies the requirements for providing a declaration for the purposes of authenticating records in response to criminal process.
- HB 2476
Directs the Oregon Health Authority to study issues related to fitness to proceed and to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.
- HB 2480
Requires the Oregon Health Authority to study behavioral health.
- HB 2481
Requires the Oregon Health Authority to study behavioral health.
- HB 2488
Requires the Oregon Health Authority to study civil commitment criteria.
- HB 2491
Requires the State Court Administrator to study courts and submit findings to the interim committees of the Legislative Assembly related to the judiciary not later than September 15, 2026.
- HB 2492
CARRIED OVER FROM THE 4/7/2025 MEETING: Requires the State Court Administrator to study courts and submit findings to the interim committees of the Legislative Assembly related to the judiciary not later than September 15, 2026.
- HB 2614
CARRIED OVER FROM THE 4/7/2025 MEETING: Directs the Oregon Public Defense Commission to study ways to improve the provision of public defense services within this state, and to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.
- HB 2639
CARRIED OVER FROM THE 4/7/2025 MEETING: Modifies the process for setting aside convictions, dismissals, contempt of court findings and guilty except for insanity judgments.
- HB 2641
CARRIED OVER FROM THE 4/7/2025 MEETING: Modifies when a prior conviction is admissible to impeach the character of a witness.
- HB 2677 ** **Subsequent Referral(s) to Ways and Means
Modifies the procedure for the expunction of certain juvenile records.
- HB 2975
CARRIED OVER FROM THE 4/7/2025 MEETING: Provides that an admission or a finding that a crime constitutes domestic violence is not an element of the crime for merger purposes.
- HB 3051
Directs the Oregon Health Authority to study fitness to proceed and requires the authority to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than May 1, 2026.
- HB 3075
CARRIED OVER FROM THE 4/7/2025 MEETING: Modifies the firearm permit provisions of Ballot Measure 114 (2022).
- HB 3076 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 4/7/2025 MEETING: Directs the Department of Justice to study the establishment of a state gun dealer licensing program, and to provide the results of the study

to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.

HB 3097

CARRIED OVER FROM THE 4/7/2025 MEETING: Increases sentencing guidelines for felony attempting to elude a police officer.

HB 3194

CARRIED OVER FROM THE 4/7/2025 MEETING: Establishes that landowners and persons acting as farmworker camp operators are jointly and severally liable for operating a farmworker camp on the landowner's property unless certain conditions are met.

HB 3323

Authorizes a driver improvement course as an alternative to conviction of a traffic violation for a person 18 years of age or less whose driving record shows no prior convictions of traffic offenses.

HB 3426

CARRIED OVER FROM THE 4/7/2025 MEETING: Expands offenses relating to the use of an unmanned aircraft system to interfere with official duties to include firefighting and search and rescue efforts.

HB 3553

CARRIED OVER FROM THE 4/7/2025 MEETING: Creates the crime of possessing, purchasing, making, delivering or selling a pill press or similar equipment.

HB 3582

CARRIED OVER FROM THE 4/7/2025 MEETING: Eliminates the statute of limitations for civil actions based on sexual assault or child sexual abuse.

HB 3766

CARRIED OVER FROM THE 4/7/2025 MEETING: Allows a plaintiff to bring a civil action against a person who transmits an intimate image to the plaintiff's computer or electronic device in certain circumstances.

HB 3819

CARRIED OVER FROM THE 4/7/2025 MEETING: Allows the State Board of Massage Therapists to issue a registration to practice reflexology to a qualified applicant.

HB 3839

CARRIED OVER FROM THE 4/7/2025 MEETING: Directs the Department of State Police to ensure that level one and level two sex offender information is available to school districts and entities providing school visitor management services.

HB 3884

CARRIED OVER FROM THE 4/7/2025 MEETING: Requires the Department of State Police to study whether firearm hold agreements reduce firearm risks.

HB 3929

CARRIED OVER FROM THE 4/7/2025 MEETING: Establishes a testimonial privilege for communications by certain public safety employees to a peer supporter.

HB 3948

CARRIED OVER FROM THE 4/7/2025 MEETING: Increases the penalty for operating an unmanned aircraft system over a critical infrastructure facility that is a correctional facility or youth correction facility.
