Public Hearing and Possible Work Session

- HB 3917 ** **Subsequent Referral(s) to Ways and Means
Creates the Catastrophic Wildfire Fund to pay for property damage claims arising from catastrophic wildfires that are ignited by the facilities of a public utility.
- HB 3926 ** **Subsequent Referral(s) to Ways and Means
Directs the Department of State Police to create the SIGNAL program (State Initiated Guidance for Notifying and Assisting the Lost).
- HB 3935
Creates the crime of initiating a false report in the first degree.

Work Session

- HB 3323
Authorizes a driver improvement course as an alternative to conviction of a traffic violation for a person 18 years of age or less whose driving record shows no prior convictions of traffic offenses.
- HB 2470 ** **Subsequent Referral(s) to Ways and Means
Directs the Oregon Health Authority to expand the capacity of the Oregon State Hospital.
- HB 2476
Directs the Oregon Health Authority to study issues related to fitness to proceed and to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.
- HB 2480
Requires the Oregon Health Authority to study behavioral health.
- HB 3051
Directs the Oregon Health Authority to study fitness to proceed and requires the authority to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than May 1, 2026.

HB 2602

Requires the Judicial Department to study ways to improve the efficiency of the process for setting aside convictions.

HB 2603

Requires the Judicial Department to study ways to improve the efficiency of the process for setting aside convictions.

HB 2604

Requires the Judicial Department to study options for simplifying family law proceedings in this state.

HB 2605

Requires the State Court Administrator to study fees and submit findings to the interim committees of the Legislative Assembly related to the judiciary not later than September 15, 2026.

HB 2611

Requires the State Court Administrator to study lawsuits and submit findings to the interim committees of the Legislative Assembly related to the judiciary not later than September 15, 2026.

HB 2623

Directs the Oregon Public Defense Commission to study best practices to improve the provision of public defense services within this state, and provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.

HB 2625

Requires the Oregon Criminal Justice Commission to study the effect of different types of sentences on rates of recidivism.

HB 2626

Requires the Oregon Criminal Justice Commission to study the effect of different types of sentences on rates of recidivism.

HB 2636

Requires the Department of Justice to study victims and submit findings to the interim committees of the Legislative Assembly related to the judiciary not later than September 15, 2026.

HB 2637

Requires the Oregon Youth Authority to study the demographics of youth receiving services from the authority.

HB 2849

Requires the Department of Public Safety Standards and Training to study issues facing law enforcement agencies.

HB 3071

Requires the Department of Justice to study crime victim services.

HB 3073

Requires the Oregon Criminal Justice Commission to study the effect of different types of sentences on rates of recidivism.

HB 3074

Requires the Department of State Police to study the efficiency of firearm transfer criminal background checks.

HB 3815

Requires the Oregon Criminal Justice Commission to study the effect of different types of sentences on rates of recidivism.
