#### Public Hearing

SB 959

Adds signal jammers that interfere with alarm system signals and communication to the definition of "burglary tool or theft device," possession of which with intent to commit or facilitate a forcible entry into premises or a physical taking constitutes the crime of possession of a burglary tool or theft device.

SB 1125 A

Increases the penalties for using an unmanned aircraft system to interfere with a wildfire suppression effort.

#### Work Session

SB 166 A

Changes the term "member" of the Oregon State Bar to the term "licensee" of the Oregon State Bar.

SB 167

Amends portions of the Uniform Commercial Code to enable the code to govern the use of certain types of digital assets, electronic money, chattel paper, hybrid transactions, including bundles of goods and services, documents of title and payment systems.

SB 168 A

Modifies evidence required to establish parentage in a probate proceeding.
