#### Public Hearing

SB 170 A

Increases the offense level of assault in the fourth degree when the defendant commits the assault against a victim performing official duties as part of the victim's employment and has certain prior convictions for assault in the workplace.

SB 473 A

Creates the crime of threatening a public official.

SB 599 A

Prohibits landlords from inquiring about or discriminating on the basis of a tenant's or applicant's immigration or citizenship status, rejecting an applicant based on the type of identifying documentation or disclosing or threatening disclosure of an applicant's or a tenant's immigration or citizenship status for improper purposes.

SB 1123 A

Grants court visitors immunity from liability when acting in good faith and within the scope of the visitor's duties.

SB 1175 A

Establishes the Task Force on Removing Barriers to Jury Service.
