#### **Public Hearing and Work Session**

HB 2459 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Provides that, beginning on January 1, 2028, the annual salary or wages paid to an officer or employee of certain state agencies may not exceed 10 times the lowest annual salary or wages paid to a full-time officer or employee of the agency.

#### HB 3374

Authorizes the State Accident Insurance Fund Corporation to form or acquire subsidiaries to perform any function the corporation may delegate under law.

#### Work Session

HB 2249

Requires the Bureau of Labor and Industries to conduct a study of matters relating to apprenticeship programs in this state.

HB 2425

Requires public bodies that procure electric vehicles and solar photovoltaic energy systems to receive before entering a contract for the electric vehicle or solar photovoltaic energy system a certification from the manufacturer, distributor, vendor or supplier that the production, assembly, transportation or sale of the electric vehicle or solar photovoltaic energy system did not use or involve forced labor or oppressive child labor.

#### HB 2548 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes the Agricultural Workforce Labor Standards Board.

HB 2799

Removes the cap on reasonable litigation costs and expenses and attorney fees for a claimant who prevails in a workers' compensation dispute.

#### HB 3363 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Modifies how the overtime cap is calculated for use in calculating the final average salary of members of the Oregon Public Service Retirement Plan.

HB 3838

Establishes the Home and Community-Based Services Workforce Standards Board.

## AGENDA (cont.) April 7, 2025

HB 3881

Adds school districts, education service districts and public charter schools to the definition of "qualifying agency" for the purpose of applying apprenticeship requirements in connection with constructing public improvement projects.

#### HB 3491

Requires the Employment Department to study issues related to the family and medical leave insurance program.

Note change: work sessions on HB 2799, HB 2548, HB 3838, and HB 3881 have been added.
