#### Public Hearing

HB 2491 A

Establishes a standardized process for courts to follow when a petition is filed for the remission of fines, fees or costs associated with a criminal case.

HB 3532 A

Directs the Oregon Historical Society, in consultation with the Oregon Geographic Names Board, federally recognized Indian tribes, state and local government leaders, local landowners and other interested parties, to compile a list of highways and geographic features that bear offensive names.

HB 3953

Allows an applicant for a public charter school that is a federally recognized Indian tribe in this state to directly apply to the State Board of Education for sponsorship.

HB 3409

Requires the Oregon Health Authority to study health care.

HB 3493

Prohibits landlords from banning political canvassing or solitication in manufactured dwelling parks and marinas.
