Public Hearing

HB 2006

Limits to 25 the number of legislative measures that a member of the Legislative Assembly may ask the Legislative Counsel to prepare for a regular session of the Legislative Assembly that begins in an odd-numbered year.

Please note: The public hearing on HB 2548 is for the purpose of taking testimony on the -7 amendments.

HB 2548 **

Establishes the Agricultural Workforce Labor Standards Board.

Please note: The public hearing on HB 3410 is for the purpose of taking testimony on the -3 amendments that will be posted on OLIS when available.

HB 3410

Requires the Oregon Health Authority to study health care.

Work Session

HB 3908

Increases the party registration requirement to be a major political party in this state from five percent to 10 percent.

HB 3963

Extends to January 1, 2027, the date by which the Department of Land Conservation and Development is to report on the department's assessment of the state enforceable policies that may be used in the federal consistency review of offshore wind leasing decisions and related actions.

SB 450

Designates November 14 of each year as Ruby Bridges Walk to School Day.

SB 547 A

Designates the month of April of each year as Oregon Native Plant Appreciation Month.

Designates February of each year as Oregon Truffle Month.
