Public Hearing

HB 3403

Requires the Department of Education to study the adequacy of education in the public schools of this state.

HB 3970

Directs the Department of Human Services and the Housing and Community Services Department to collaborate on recommendations for funding to meet the needs of youth experiencing homelessness.

HB 3974

Limits the applicant screening charge a residential landlord may collect to \$20.
