Public Hearing

SB 1014

Requires the Secretary of State to allow to be included in the translated version of each state voters' pamphlet that is made available on the website of the secretary or of a county the translations of a party's statement of arguments for the success of its principles and election of its candidates.

SB 578

Establishes the dates by which a candidate or the candidate's agent must file a portrait and statement for purposes of being included in a county voters' pamphlet.

SB 580 A

Requires filing officers in each county and city to make publicly available on the county or city website certain election documents that are filed with the filing officer within a specified period.

SB 224 A

Prohibits the Secretary of State from publishing the residence address of certain individuals who are affiliated with apolitical committee on the electronic filing system maintained by the secretary.
