HB 3525 A

Requires, for each dwelling unit rented by a landlord for which the source of drinking water is an exempt well, that the landlord collect and test samples of drinking water from the dwelling unit for arsenic, Requires, for each dwelling unit rented by a landlord for which the source of drinking water is an exempt well, that the landlord collect and test samples of drinking water from the dwelling unit for arsenic, coliform bacteria, lead and nitrates.

HB 3954

Prohibits the Adjutant General for assisting or allowing the United States Department of Defense or any branch thereof to communicate with any individual or unit of the Oregon National Guard for purposes of calling the individual or unit into active service unless the active service is for a certain listed reason.

SB 243 B

Creates the crime of unlawful transport, manufacture or transfer of a rapid fire activator.
