#### Work Session

HB 2814

Authorizes the Department of Early Learning and Care to waive certain requirements for certified child care facilities upon good cause shown and if the resulting circumstances protect the welfare of the children and the consumer interests of the parents of the children.

HB 3211 A

Requires the Oregon Health Authority to develop and make available a nonopioid directive form.

HB 3560 A

Expands areas where a child care facility may be sited.

Includes outpatient facilities with a certified substance use disorder program that employ certified alcohol and drug counselors as providers for the purposes of mental health treatment insurance coverage.
