#### Public Hearing

SB 141

Requires the Department of Education to study methods for increasing the accountability of the public education system of this state.

SB 472

Authorizes an education service district board to determine whether a district school board has violated a requirement regarding actual conflicts of interest.

#### Work Session

SB 310

Requires only one party to file a petition for a fact finder if the public employer is a public education employer.

SB 313 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs the Oregon Department of Administrative Services to develop an implementation plan for a statewide collective bargaining process for licensed educators in this state.

SB 604 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes the Strong Start Program within the Higher Education Coordinating Commission for purposes of providing support to first-year and underrepresented students at public universities in this state.

SB 868

Directs the Department of Education to develop a formula and to submit a report related to the calculation of the cost of operating and administering a local, county or regional program of special education.
