Public Hearing

HB 2900 A

Modifies the definition of "contract teacher" for the purposes of the Accountability for Schools for the 21st Century Law.

HB 3026 A

Modifies eligibility requirements for a scholarship program for teacher candidates.

HB 3365 A

Directs the State Board of Education to ensure that academic content standards for core subjects include sufficient instruction on the causes and effects of climate change and strategies for responding to such causes and effects.

HB 3731 A

Provides additional data to be included by institutions of higher education in an annual report regarding allegations of sexual misconduct and violence on the campus of the institution.

Work Session

HB 2530 A

Modifies school bus stop arm camera law.

HB 2586 A

Permits an asylum seeker who is a student at a public university in this state or Oregon Health and Science University to receive an exemption from nonresident tuition and fees.

Requires the Oregon Health and Science University Board of Directors to include specified individuals in the search and hiring committees for a president of the university.
