#### Public Hearing

- SB 827 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Expands the Oregon Solar and Storage Rebate Program to offer rebates for energy storage systems that will be paired at the time of installation with previously purchased and installed solar electric systems.
- SB 828 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Establishes the Grid Resilience Matching Fund.
- SB 825  
Requires the program for state agency facility energy design to minimize costs of reports to state agencies and minimize duplication of reporting requirements under the energy performance program for covered commercial buildings.
- SB 929  
Appropriates moneys from the General Fund to the State Parks and Recreation Department for planning and coordination to continue to develop, maintain or work toward completion of the Oregon Coast Trail.
