#### Public Hearing

SB 685

CARRIED OVER FROM THE 2-10-2025 MEETING: Requires a public utility to obtain authorization from the Public Utility Commission to develop or carry out a project that involves the production or use of hydrogen in this state.

SB 551

Prohibits restaurants and retailers from providing reusable plastic checkout bags to consumers.

SB 526

Prohibits the sale of new clothes washers that are not equipped with a microfiber filtration system, beginning January 1, 2030.

SB 139

Permits sharps and other solid waste to be consolidated in a single container, subject to certain requirements.
