#### Public Hearing

- SB 597 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs the Oregon Health Authority to establish a grant program to provide financial support to certified dental sealant programs that promote and engage in oral health care coordination activities.
- SB 822 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Expands network adequacy requirements to health benefit plans offered to large employers and modifies requirements.
- SB 824 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires the Department of Consumer and Business Services to study federal laws and regulations affecting health insurance and evolving conditions in the insurance market that require periodic updates to state laws.
- SB 837 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Modifies laws governing the emergency health care provider registry to allow a broader range of volunteer services and allow deployment of volunteers outside of declared emergencies.
- SB 842  
Increases for hospitals the annual license fees to be obtained by the Oregon Health Authority.
