- SB 531 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs the Oregon Department of Administrative Services to distribute moneys to the Oregon Wellness Program for specified purposes.
- SB 718 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Establishes the Parkinson's disease registry.
- SB 873  
Repeals a license issued by the Oregon Medical Board to certain physicians licensed to practice in other jurisdictions.
- SB 874  
Defines "Oriental medicine."

#### Public Hearing

- SB 528 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Appropriates moneys to be used for regional health equity coalitions.
- SB 530 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires the Oregon Health Authority to adjust for inflation the amount of any grant awarded to a regional health equity coalition.
- SB 778 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires the Oregon Health Authority and coordinated care organizations to provide reimbursement for air ambulance services provided to medical assistance recipients at rates in accordance with the national Ambulance Inflation Factor.
- SB 476  
Requires professional licensing boards to provide culturally responsive training to specified staff members and publish guidance on pathways to professional authorization for internationally educated individuals.
