- SB 1050 \*\* \*\*Subsequent Referral(s) to Ways and Means Appropriates moneys from the General Fund to the Oregon Department of Administrative Services for distribution to Southern Coos Hospital and Health Center to expand access to primary, specialty and pharmacy services in and around Bandon, Oregon.
