SB 537

Creates workplace violence prevention requirements for certain health care entities.

SB 441 **

**Subsequent Referral(s) to Ways and Means

Removes the requirements for notification of substitution and records retention for prescribed biological products.

SB 716 **

**Subsequent Referral(s) to Ways and Means

Requires the Oregon Health Authority to adopt rules for registering urgent care centers and specifies requirements.

SB 1000 **

**Subsequent Referral(s) to Ways and Means

Appropriates moneys from the General Fund to the Oregon Department of Administrative Services for distribution to Bay Area Hospital in Coos Bay.

SB 1001 **

**Subsequent Referral(s) to Ways and Means

Appropriates moneys from the General Fund to the Oregon Department of Administrative Services for distribution to the Coast Community Health Center to provide health care services and apprenticeships.

SB 1050 **

**Subsequent Referral(s) to Ways and Means

Appropriates moneys from the General Fund to the Oregon Department of Administrative Services for distribution to Southern Coos Hospital and Health Center to expand access to primary, specialty and pharmacy services in and around Bandon, Oregon.
