#### Public Hearing

HB 2016 A

Requires the Oregon Board of Licensed Professional Counselors and Therapists to establish a schedule of violations and remove from the board's website and publicly accessible publications, other than from a searchable electronic database designed to enable licensure or registration verification, information related to a licensee's or associate's violations after a specified time.

HB 2205 A

Requires a contract entered into between the Oregon Health Authority and a coordinated care organization to be for an initial term of no less than five years and to be the same length for all coordinated care organizations contracting with the authority.

HB 3942 A

Allows a person or government unit to use an expedited licensure process to operate a health care facility, if the license is to operate a health care facility in the same physical location and of the same type as a health care facility that previously operated at the location and the previously operated health care facility closed within the last 24 months voluntarily or due to financial hardship.
