HB 2205 A

Requires a contract entered into between the Oregon Health Authority and a coordinated care organization to be for an initial term of no less than five years and to be the same length for all coordinated care organizations contracting with the authority.

HB 2940 A

Directs the Oregon Health Authority to implement a program for providing to emergency departments in real time notifications that identify patients with hemoglobinopathies and provide information on how to contact a hematologist.

HB 3942 A

Allows a person or government unit to use an expedited licensure process to operate a health care facility, if the license is to operate a health care facility in the same physical location and of the same type as a health care facility that previously operated at the location and the previously
