#### Public Hearing

SB 64 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires the Department of Human Services to seek a waiver of federal requirements in the Supplemental Nutrition Assistance Program in order to allow recipients of supplemental nutrition assistance to receive advance installment payments of the tax credit for dependent care expenses.

SB 138  
Modifies the centralized child abuse reporting system requirements to allow, but not require, the Department of Human Services to include a website for electronic reports of suspected child abuse.

SB 452 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Appropriates moneys from the General Fund to the Oregon Department of Administrative Services for distribution to Marion-Polk Food Share, Inc.

SB 815  
Modifies juvenile dependency procedures regarding when the Department of Human Services is recognized as a party in a proceeding.
