#### Public Hearing

SB 736

Creates an exception to abuse of a child in care provisions when the suspected abuse was committed by the parent of the child in care.

SB 743

Requires the Department of Human Services or a law enforcement agency to electronically record certain interviews in child abuse investigations.

SB 912

Prescribes duties to protect children and provide for children's basic needs.

SB 915

Directs the Director of Human Services to ensure that standards and procedures for the assessment and investigation of reports of child abuse committed by certain persons are investigated by a department program that specializes in training, investigations and safety.

SB 135

Requires the appointment of court appointed special advocates to specified advisory councils, advisory committees and review teams.

Those who choose to participate may submit written testimony rather than verbal, and written comments will be included in the public record.
