Public Hearing

SB 170

Requires the Oregon Criminal Justice Commission to study workplace assault convictions and sentences.

SB 389

Allows a person to petition for an order restraining a respondent from harassment of the petitioner.

SB 804

Authorizes the Teacher Standards and Practices Commission to impose civil penalties or order payment of the costs of disciplinary proceedings.

SB 872

Modifies laws related to the State Mortuary and Cemetery Board's authority to impose disciplinary actions on applicants and those subject to the board's regulatory authority.

Possible Introduction of Committee Measures

Please note: The following bill is scheduled solely for the purpose of moving it back to the Senate President's desk for referral to another committee.

SB 723

Requires that trains have a minimum of two crew members.

SB 300

CARRIED OVER FROM THE 2/24/2025 MEETING: Modifies the definition of "private security entity" for purposes of private security requirements.

SB 557

CARRIED OVER FROM THE 2/24/2025 MEETING: Requires at least one of the commissioners of the Oregon Liquor and Cannabis Commission to hold a marijuana processor, marijuana producer, marijuana retailer or marijuana wholesaler license.

SB 870

CARRIED OVER FROM THE 2/24/2025 MEETING: Exempts from public records disclosure the residential address and personal phone number of an individual who holds a specified permit issued by the Oregon Liquor and Cannabis Commission.
