#### Public Hearing

SB 1114

Limits the total term of commitment and conditional release for certain persons found guilty except for insanity to the sentence the person would have received under the sentencing guidelines or as required by a mandatory minimum sentence.

SB 1175

Establishes the Task Force on Removing Barriers to Jury Service.

#### Work Session

SB 832

Makes certain changes related to civil penalties for violations related to disease control.

SB 1176

Requires the Bureau of Labor and Industries to conduct an effort to publicize and explain the obligation to accept cash as payment for goods and services to places of public accommodation and residents of this state.

SB 1122

Provides that the sex offender risk assessment methodology used to classify sex offenders into risk levels may exclusively consider a sex offender's risk of reoffending at the time of release, sentencing or discharge.
