SB 1015 **

**Subsequent Referral(s) to Ways and Means

Requires the Department of Justice to develop and implement a grant program to award moneys to eligible entities to reduce community violence in communities experiencing disproportionately high rates of community violence.

SB 1121

Creates the crime of unlawful disclosure of private information.

Placeholder Bills that do not currently have planned amendments:

SB 182

Requires the Oregon Health Authority to study civil commitment criteria.

SB 184

Requires the State Court Administrator to study civil procedure and submit findings to the interim committees of the Legislative Assembly related to the judiciary not later than September 15, 2026.

SB 189

Requires the Oregon Liquor and Cannabis Commission to study cannabis.

SB 192

Requires the Oregon Criminal Justice Commission to study the effect of different types of sentences on rates of recidivism.

SB 193

Directs the Oregon Criminal Justice Commission to study the use of technology to improve accuracy when measuring recidivism rates of persons convicted of felonies, and to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.

SB 195

Requires the Department of Corrections to study best practices for confining people.

SB 276

Directs the Oregon Criminal Justice Commission to study the effect of different types of sentences on recidivism rates, and to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.

SB 278

Requires the Department of Justice to study victims and submit findings to the interim committees of the Legislative Assembly related to the judiciary not later than September 15, 2026.

SB 1149

Requires the Department of Consumer and Business Services to study insurance for rural electric cooperatives.

SB 1150

Requires the Department of Consumer and Business Services to study insurance.

SB 1151

Requires the Public Utility Commission to study investor-owned utilities.

SB 1170

Requires the Department of Justice to study access to justice.

Note change: SB 1015 added.
