Public Hearing and Possible Work Session

SB 195

Requires the Department of Corrections to study best practices for confining people.

SB 1015 **

**Subsequent Referral(s) to Ways and Means

Requires the Department of Justice to develop and implement a grant program to award moneys to eligible entities to reduce community violence in communities experiencing disproportionately high rates of community violence.

SB 1121

Creates the crime of unlawful disclosure of private information.

Work Session

SB 149

CARRIED OVER FROM THE 4/7 MEETING: Requires the Department of Human Services to study immigration.

SB 163

CARRIED OVER FROM THE 4/7 MEETING: Requires the Judicial Department to study the judicial and administrative procedures to establish parentage and changes that would be necessary to implement the Uniform Parentage Act in this state.

SB 174

CARRIED OVER FROM THE 4/7 MEETING: Provides that a violation of prohibitions against certain practices with respect to insurance is subject to an enforcement action under the Unlawful Trade Practices Act.

SB 176 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4/7 MEETING: Removes requirements that a registry identification cardholder who produces marijuana for personal medical use register with the Oregon Health Authority.

SB 243

CARRIED OVER FROM THE 4/7 MEETING: Requires the Department of State Police to study the efficiency of firearm transfer criminal background checks.

SB 469

CARRIED OVER FROM THE 4/7 MEETING: Requires the State Board of Parole and Post-Prison Supervision to study parole law in this state.

SB 556

CARRIED OVER FROM THE 4/7 MEETING: Allows a marijuana producer, marijuana wholesaler, marijuana processor or marijuana retailer to use a motion detection camera system at a licensed premises.

SB 926

CARRIED OVER FROM THE 4/7 MEETING: Prohibits the recovery from customers of certain costs and expenses that an electric company incurs as a result of allegations of a wildfire resulting from the negligence or a higher degree of fault on the part of the electric company.

SB 1003

CARRIED OVER FROM THE 4/7 MEETING: Modifies provisions relating to the Oregon Death With Dignity Act.

SB 1173

Provides that a health care facility is not a manufacturer, distributor, seller or lessor of a product for purposes of a product liability civil action if the health care facility was not involved in the design or manufacture of the product.

Requires the Oregon Health Authority to study civil commitment criteria.

SB 201

SB 202

SB 240

Requires the Judicial Department to study options for simplifying family law proceedings in this state.

SB 245

Requires the Department of Consumer and Business Services to study insurance.

SB 251

Requires the Department of Public Safety Standards and Training to study the Oregon State Police.

SB 253

Directs the Oregon Public Defense Commission to study ways to improve the provision of public defense services within this state, and to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.

SB 256

Requires the State Board of Parole and Post-Prison Supervision to study issues related to parole.

SB 258

Directs the Oregon Public Defense Commission to study best practices to improve the provision of public defense services within this state, and provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.

SB 260

Requires the Oregon Criminal Justice Commission to study the effect of different types of sentences on rates of recidivism.

SB 268

Directs the Oregon Criminal Justice Commission to study the effect of sentencing types on recidivism rates of sex offenders, and to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.

SB 269 **

**Subsequent Referral(s) to Transportation

Directs the Department of Transportation to study issues related to traffic offenses and to report to an appropriate committee or interim committee of the Legislative Assembly on or before September 15, 2026.

SB 276

Directs the Oregon Criminal Justice Commission to study the effect of different types of sentences on recidivism rates, and to provide the results of the study to the appropriate interim committees of the Legislative Assembly no later than December 31, 2026.

SB 278

Requires the Department of Justice to study victims and submit findings to the interim committees of the Legislative Assembly related to the judiciary not later than September 15, 2026.

SB 1149

Requires the Department of Consumer and Business Services to study insurance for rural electric cooperatives.
