#### Public Hearing

HB 2522

Requires the use of headlights when the windshield wipers are on or there is fog.

HB 2613 A

Prescribes the factors that the court must consider when determining whether a child is in immediate danger for the purpose of granting a request for a temporary order providing for the custody of, or parenting time with, the child.

HB 3605 A

Punishes a violation of the laws that regulate home solicitation sales as an unlawful practice under the Unlawful Trade Practices Act.

HB 3865 A

Prohibits as an unlawful practice under the Unlawful Trade Practices Act a person's initiating a telephone solicitation outside specified hours or more than three separate times within a 24-hour period, misrepresenting or falsifying the person's identity, the purpose of the call or the location from which the person is calling or failing to make required disclosures or inquiries during the call.
