Public Hearing

HB 3564 A

Modifies provisions relating to demands for correction or retraction of a published defamatory statement.

HB 3816 A

Provides for 50 percent of awards of restitution ordered to an insurance carrier to be paid to the Department of Justice for purposes of victim services funding.

HB 3819 A

Allows the State Board of Massage Therapists to post a placard on the exterior of a massage facility found to have committed specified violations.

HB 2119 A

CARRIED OVER FROM 5/7 MEETING: Provides for standing for an association or organization to seek declaratory relief in the Oregon Tax Court.

HB 2460 A

Updates, reorganizes and modifies the provisions governing appeals from justice courts that have not become courts of record.

HB 2522

CARRIED OVER FROM 5/7 MEETING: Requires the use of headlights when the windshield wipers are on or there is fog.

HB 2819 A

CARRIED OVER FROM 5/7 MEETING: Authorizes the State Forester or a person authorized by the State Forester to issue citations if there are reasonable grounds to believe violations have occurred.

HB 2916

CARRIED OVER FROM 5/7 MEETING: Modifies the qualifications of the fire instructor representative member of the Fire Policy Committee of the Board on Public Safety Standards and Training.

HB 2926

CARRIED OVER FROM 5/7 MEETING: Allows the Department of Public Safety Standards and Training to proceed with an investigation of, or action to deny the application for training or deny the certification of, a public safety officer or instructor notwithstanding a subsequent change in the employment status of the officer or instructor.

HB 3825 A

CARRIED OVER FROM 5/7 MEETING: Provides that judgment remedies for judgments of conviction in municipal and justice courts for the possession of less than one ounce of marijuana expire on the effective date of the Act.

Note change: HB 2119 A, HB 2522, HB 2819 A, HB 2916, HB 2926, and HB 3825 A added.
