SB 397

Provides that laws regarding employee entitlements for recovery of unpaid wages and penalties do not apply to wages and penalties lost as a result of an employer's time-rounding policies that comply with federal rounding standards.

SB 463 **

**Subsequent Referral(s) to Ways and Means

Requires the Oregon Department of Administrative Services to submit by August 30 of each even-numbered year a report to the Legislative Assembly concerning the soundness of the state's Insurance Fund.

SB 760

Requires the owner of a public building to periodically conduct inspections and testing of fire dampers, smoke dampers, combination fire and smoke dampers and smoke control systems in the public building.

SB 859

Authorizes the Director of the Employment Department to compromise or adjust certain debts and overpayments relating to the paid family and medical leave program.
