#### Work Session

HB 2127 A

Makes various changes to the laws that govern franchise agreements between motor vehicle dealers and manufacturers, distributors and importers.

HB 2541

Provides certain agricultural workers with rights to express breast milk in the workplace.

HB 3020 A

Prohibits wagering on dog races.

HB 3021 A

Makes changes to statutes related to unemployment insurance law and paid family and medical leave insurance law.

HB 3115 A

Prohibits the transfer, for consideration, of winning Oregon State Lottery tickets or shares above a certain value.

HB 3447

CARRIED OVER FROM THE 04-15-2025 AGENDA: Requires a business that makes retail sales of certain nitrous oxide canisters to verify the recipient is at least 18 years of age.

#### Public Hearing

HB 2373 A

Prohibits selling or offering for sale a timeshare without a license.

HB 3178 A

Requires a seller in a motor vehicle transaction that involves a retail installment contract or lease agreement to make a good faith effort to sell the retail installment contract or lease agreement to a lender on the exact terms that the seller and buyer negotiated.

HB 3370

Modifies the time frame in which state agencies may submit information to financial institutions related to deceased members or depositors.

HB 3724

Prohibits advertising, packaging and labeling of marijuana items in a manner likely to cause minors to unlawfully possess or consume marijuana items.
