#### **Work Session**

HB 2425 A

Establishes the Task Force on Ethical Procurement with 11 members appointed by the President of the Senate, the Speaker of the House of Representatives and the Governor.

HB 3167 A

Prohibits willfully selling or using software that is designed to circumvent, thwart, interfere with or evade a control or measure, including a security measure or an access control system, that an operator, ticket seller or reseller establishes or uses to ensure an equitable distribution, sale or resale of admission tickets for an entertainment event, including a public or private presale of admission tickets.

## **Public Hearing and Work Session**

HB 2957 A

CARRIED OVER FROM THE 05-13-2025 AGENDA: Prohibits employers from entering into agreements that shorten the statute of limitations with respect to violations over which the Bureau of Labor and Industries has enforcement authority.

### **Public Hearing**

HB 2563 A

CARRIED OVER FROM THE 05-13-2025 AGENDA: Requires an insurer to provide to an insured a clear and reasonable explanation of the reasons for any increase in the premium amount for a qualified policy upon renewal of the qualified policy.

HB 3024

CARRIED OVER FROM THE 05-13-2025 AGENDA: Eliminates the reduction of an individual's maximum benefit amount by eight times the individual's weekly benefit amount after the individual is disqualified from the receipt of benefits for cause and has not earned at least four times the individual's weekly benefit amount.
