#### Public Hearing

- HB 2256 A  
Exempts the seller and a nonprofit, public body or tribe that purchases property for conservation purposes from civil or criminal liability for selling certain units of land not lawfully established.
- HB 2343 A  
Extends a sunset on the Columbia River Fisheries Enhancement Fund.
- HB 2345  
Renames the Oregon Hatchery Research Center Fund.
- HB 2817  
Eliminates the closure of forestland, due to fire danger, by permit closure.
- HB 3487 A  
Authorizes counties that receive moneys from the State Department of Agriculture under a past appropriation to use up to eight percent of the moneys to pay expenses incurred in administering grasshopper suppression efforts.
- HB 3814 A  
Authorizes the Environmental Quality Commission and the Department of Environmental Quality to allow for a mixing zone to meet bacteria water quality criteria in a permit applicable to a seafood processing facility.

#### Possible Work Session

- HB 2163  
Classifies a person with a documented intellectual or developmental disability as a person with a disability for purposes of wildlife laws that pertain to angling and harvesting shellfish.
- HB 2170 A  
Authorizes the State Department of Fish and Wildlife, the State Marine Board or the State Department of Agriculture to enter into an intergovernmental agreement with a tribal

government, local government or a local service district to perform aquatic invasive species inspections at check stations.

HB 2978 A

Makes certain changes concerning a program to reduce wildlife-vehicle collisions.

HB 3141 A

Designates the third Tuesday of March of each year as Oregon Farmer and Rancher Day.
