#### Public Hearing

SB 12

Prohibits the designation of incumbent for any candidate for specified judgeships who was appointed and is seeking election in the first election since that appointment.

SB 964

Defines "postal indicator" as an official mark stamped on an envelope by the United States Postal Service for purposes of determining the date or time at which a ballot was mailed.

SB 1054

Requires each county clerk in this state to provide a live video feed to be made available to the public through the Internet of rooms in which ballots are tallied and official ballot drop sites.

#### Work Session

SB 790

Modifies the statute that governs the fee schedule for public records filed with a county clerk.

HB 3386

Authorizes a deputy of a county clerk to solemnize marriages.
